Additional Comments:

Ulster Wildlife welcomes the publication of a policy statement on 'Environmental Principles' and recognises the aims and objectives, particularly the integration of environmental principles into all policy making and the continuity of environmental standards post-Brexit.

We understand from the document that the aim is to 'empower ministers and those working on their behalf to think creatively and use environmental principles in an innovative and forward-thinking way'

And the desired outcomes on page 3 summarise the need for policy makers to consider environmental protection, sustainable development, avoidance of environmental damage, mitigation where it is appropriate, application of the 'precautionary and 'the polluter pays' principles.

Additional Comments:

We recognise the importance of the Environmental Improvement Plan in informing and delivering targets for application of the Environmental Principles. However, there has been no formal opportunity to consult on this document

Understanding the Statement and the Due Regard Duty

7 Is there enough information provided on the due regard duty to effectively assistpolicy makers to comply with the statement?

Additional Comments:

The statement defines what the "due regard" duty entails. However, it is unclear if this is to consider the specific environmental principles when developing or revising policy, or to the draft 'Statement'. We would obviously prefer if this due regard was to the specific principles.

It would also be good to clarify at what levels of policy making this applies outside of Government Departments.

The statement offers practical advice on how policymakers should demonstrate their compliance, e.g. keeping records of considerations, and revisiting delivery throughout the policy cycle and we recognise that there are exemptions, which have been clearly stated.

Policymakers would benefit from more examples of how due regard has been applied in policy contexts to demonstrate best practices.

The provision of templates would be helpful in ensuring these tools are applied consistently across different departments.

Additional Comments:

The descriptions are sound, but the inclusion of specific case studies to show how the principles have been applied successfully could assist policymakers further in their application.

Particularly more explicit guidance on how to weigh up environmental, social, and economic factors in challenging scenarios.

If Northern Ireland is to take environmental protection seriously, the application of these principles must be bolstered through the development of both the policy statement and the duty to apply principles.

More examples of reporting and standardised templates to ensure consistency across Departments would be beneficial

Comments:

To successfully apply these principles to achieve meaningful environmental protection they should be accompanied by a duty to apply the principles. Ulster Wildlife would therefore support the requirement on DAERA to publish a statement of policy in relation to the application and interpretation of the environmental principles, with input from experts and scrutiny from the Assembly.

There are related considerations to the environment that could be applied in time, such as biodiversity net gain, or current issues such as equality that need to be addressed as part of the decision-making process and these should be acknowledged in any templates for respondees to consider.
